L. W. Johnson hereby files the following declaration of lien against James B. Drake:

First. Said L. W. Johnson claims a lien of lot commencing at a point on Prairie Branch six hundred and sixty six (666) yards south of where the East and West section line between sections fifteen (15) and twenty-two (22) in township (20), Range three (3) West crosses said branch, and thence south and up said branch two hundred and fourteen (214) yards to where the forty (40) line crosses said branch, thence East along a ditch and continuing East along the forty (40) line <sup>to</sup> section line between sections twenty-two (22) and twenty-three (23) in township twenty (20), Range three (3) West, thence north along said section line two hundred fourteen (214) yards to land now owned by T. B. Mullin, thence west along the line between this and T. B. Mullin's land to point of beginning, containing twenty (20) acres more or less. Also fifteen (15) acres in S.W.  $\frac{1}{4}$  of N.W.  $\frac{1}{4}$  of section twenty-three (23), Township twenty (20) Range three (3) West, described as follows:

Beginning at a point on section line between sections twenty-two (22) and twenty-three (23), Township twenty (20), Range three (3) West, One hundred and sixty five (165) yards north of southwest corner of southwest quarter of Northwest quarter (S.W.  $\frac{1}{4}$  of N.W.  $\frac{1}{4}$ ) section twenty-three (23) Township <sup>Twenty</sup> (20), Range three (3) West, and thence north along said section line One hundred and Sixty five (165) yards to T. B.

Mullins land, thence East four hundred and forty (440) yards to the East line of the said forty (40) acres, thence South one hundred sixty five (165) yards along said line, thence west four hundred forty (440) yards to point of beginning.

Also he claims a lien on the building and improvements situated on said lot, to-wit: A <sup>one</sup> story frame and log dwelling house, four rooms and hall.

Second. That said lien is claimed by said Johnson for lumber and building material used for repairing, altering and beautifying the said building and improvements situated on said lot, and the building thereon under and by virtue of a contract with said owner James B. Drake, and that the amount of the same after all just credits have been given is forty-nine (\$49.00) dollars with interest at eight percent (8%) since the 30th day of December, 1915, which amount is true and correct, and that said James B. Drake is the owner of the said land and the buildings and improvements situated thereon, and that the said amount is still due and unpaid.
