This Cause coming on to be heard, was submitted for final decree upon pleadings and proof as noted by the Register, and the same having been duly considered and understood by the Court, it is the opinion of the Court that the Complainants are entitled to relief.

It is therefore ordered, adjudged and decreed by the Court, that the Complainants G. D. Leonard, Addie Hinton and Fannie Evans are the owners of the land described in the Bill of Complaint in this Cause to-wit:

Southwest Quarter of the Southwest Quarter (S. W. 1/4 of S. W. 1/4), Section fourteen (14) Southeast Quarter of Southeast Quarter (S. E. 1/4 of S. E. 1/4) Section fifteen (15) and West half of Northwest Quarter of North West Quarter (N. 1/2 of N. W. 1/4 of N. W. 1/4) Section twenty-three (23), all of which land is situated in Township Twenty-one (21) South, Range two (2) West, in Shelby County, Alabama.

That the Respondents, Lucy Bailey, Lottie Trasher, John Leonard, J. F. Leonard, William Leonard, Mattie Lawler, George Leonard, May Gray, Laura Leonard, Ethel Hinkle, Russ Leonard, Ruth Johnson, Cecil Leonard and Jack Leonard have no interest right, title or claims in and to said property; that whatever right, title, interest or claim said named respondents have in and to said property hereinbefore described is hereby divested out of them, and each of them, and is vested into Complainants G. D. Leonard,

Fannie Evans and Addie Winton.

It appearing to the Court that J. L. Peters was appointed and served as guardian ad litem for the minor Respondents Cecil Leonard and Jack Leonard, it is ordered and considered and adjudged by the Court that a fee of \$15.00 be and the same is hereby fixed as the reasonable compensation for said services, to be paid as Costs in this case, as hereinafter decreed.

It is further ordered, adjudged and decreed by the Court that the Respondents Lucy Bailey, J. M. Leonard, S. F. Leonard and Lattie Brasher pay one half the costs of this proceeding for which execution may issue; that Complainant pay one half costs of this proceeding for which execution may issue.
