Noted by the Register. And the same having been duly considered by the Court, it is ordered, adjudged and decreed that Complainant is entitled to relief that she is the owner of the following described real estate, to-wit:

All of the $6\frac{1}{2}$ & N.E. $\frac{1}{4}$ of Section 32 Township 21.S. Range 3 West, except the following lots, to-wit: One acre of land beginning at the N.E. Corner of said Tract of land and running West 85-yards, thence South 55-yards, thence East 85-yards, thence North 55-yards to the point of beginning.

Also except 20 acres, described as follows: Beginning at the S.W. Corner of the E. $\frac{1}{2}$ of N.E. $\frac{1}{4}$ of N.E. $\frac{1}{4}$ of said Section, and run South $4\frac{1}{2}$ degrees East 9.07 chains to an elm tree, thence North 81 degrees West 8.84 chains to a spring branch, thence North 65 degrees West 5 chains to the Center of the spring, thence West 16.18 chains to the West line of said $6\frac{1}{2}$ & N.E. $\frac{1}{4}$ of said Section, thence North along the West line of said South $\frac{1}{2}$ of N.E. $\frac{1}{4}$ 5.52 chains to the N.W. Corner of the same, thence East along the North line of said South $\frac{1}{2}$ of N.E. $\frac{1}{4}$ 29.04 chains to the point of beginning, containing in all the lands herein conveyed, 59 acres more or less.
