The $E\frac{1}{2}$ of the $S.W\frac{1}{4}$ of Section 11, also the $E\frac{1}{2}$ of the $S.E\frac{1}{4}$ of said Section 11, less 10 acres in the N.E. Corner of the $S.E\frac{1}{4}$ of the $S.E\frac{1}{4}$ of said Section 11 also the following described lands situated in Childan County, State of Alabama to-wit: The $N\frac{1}{2}$ of $N.W\frac{1}{4}$ and $S.W\frac{1}{4}$ of $N.W\frac{1}{4}$ of Section 14.
