South-west quarter of South-west quarter, Section Twenty-eight (28)
Also South-east quarter of South-west quarter of Section Twenty-eight (28), that lies west of Camp Branch. Also a strip off of land eight rods wide running East and West from the South side of North-east quarter of South-east of Section Twenty-nine (29), and North-west quarter of South-west quarter of Section Twenty-eight (28), and all that portion of North-east quarter of South-west quarter Section Twenty-eight (28) lying West of Camp Branch, and all of that portion South-east quarter of South-east quarter Section Twenty-nine (29) lying north of the old Eberhagen road, and east of the L & N.
