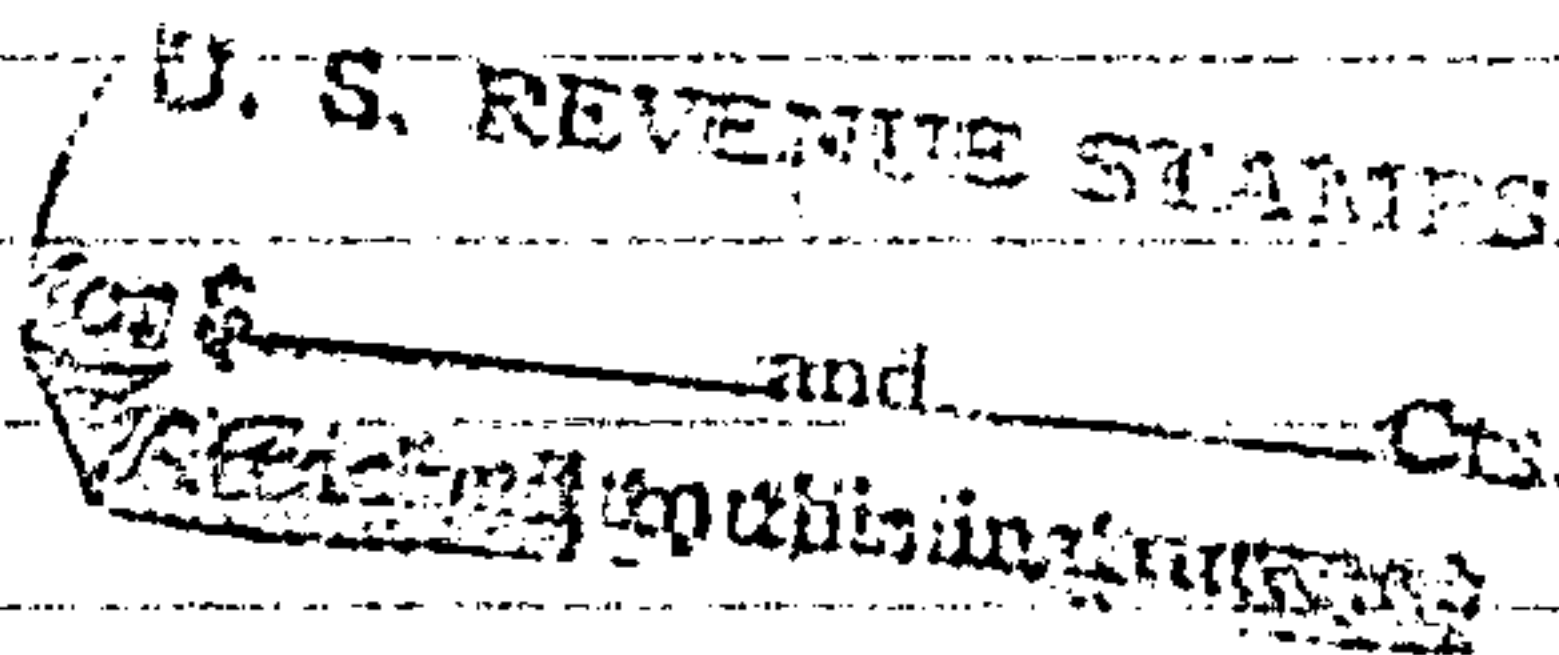


THE STATE OF ALABAMA, Shelby COUNTY.
