

Right of Way Deed for Public Road.
State of Alabama
Shelby County}

Know all men by these Presents That we
the undersigned Edmund Dolcombe President
Dolcombe Mercantile Co of the County
and State aforesaid, in and for the
consideration of one dollar (\$1.00) in
hand paid by Shelby County, the receipt
whereof is hereby acknowledged, and for
the further consideration of the benefits
accruing to us and to the public from
the construction of a public road through
our lands, we do hereby give, grant, bar
gain, sell and convey unto Shelby County
its successors or assigns, a right of
way hereinafter described over and
across the lands of the undersigned.

for a public road: which right of way shall be 50 feet in width or 25 feet in width on each side of the center line of the said road as it is now located and staked out by the State Highway Department designated as T.A.P. #99 or as much of our lands as is required to make a 50 foot right of way across our lands which are located and described as follows to-wit:

Beginning at the intersection of the south line of the south $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 11, Township 24N Range 13E and the center line of the said road thence along a 2° curve to the right 10 feet more or less to the point of tangent of said curve, thence N $5^{\circ} 50' E$ 685 feet more or less to the intersection of the north line of the said south $\frac{1}{2}$ of the said quarter-quarter section and the center line of said road the above described tract of land lying in the south $\frac{1}{2}$ of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of section 11, Township 24N Range 13E, Shelly County and containing 0.8 acres more or less and for and in consideration of the benefit to our property by reason of the construction of said road we hereby release the county from all consequential damages present or prospective to our property arising out of the construction, maintenance or repair of said road and that said road is a benefit to our property is hereby admitted and acknowledged.
