Johnson whb, being first duly sworn by me, deposes and says as follows: That he has been acquainted with the following lands for more than thirty years viz: The S $\frac{1}{2}$ of NE $\frac{1}{4}$, W $\frac{1}{2}$ of SE $\frac{1}{4}$, W $\frac{1}{2}$ of E $\frac{1}{2}$ of SE $\frac{1}{4}$, E $\frac{1}{2}$ of SW $\frac{1}{4}$, and all that part of the west half of SW $\frac{1}{4}$ lying north and east of a line beginning 98 links north of SW corner of SW $\frac{1}{4}$, thence south 82 degrees 15 minutes east 20.52 chains, thence north 16 dgrees 45' west, 10.54 chains, thence south 76 degrees 30' west 6.19 chains, thence north 18.75 chains, thence west 11.50 chains to the west line of said section, all in Sec. 24, Tp. 22 S.
