KNOW ALL MEN BY THESE PRESENTS: that whereas on 2 day of June, A.D. 1924, the Probate Court of helby county rendered a decree for the sale of lands hereinafter described and conveyed for the payment of State and County taxes then due from W. M. Moore the owner of said lands, for the payment of the fees, costs and expenses of and under said decree, and the sale had in execution thereof.

And whereas, threafter to-wit: on the 12 day of July, 1924, under and in pursuance of said decree, said lands were regularly offered for sale by the Tax Collector of Shelby County for said taxes, fees, costs and expenses, and no person having bid a sufficient sum for said lands to pay the same, said lands were bid in for the State for the sum of said taxes, fees, costs and expenses.

And whereas said lands having been entered upon the books of this Department and the Auditor and Treasurer of this State, with the approval of the Governor, have fixed the price of said land, and ascertained that the sum of One Hundred & No/100 (\$100.00) Dollars is sufficient to cover and satisfy all claims of the State and County against said lands for on on account of taxes, interest fees, and costs and officers fees which were due upon or have accrued against said lands, as provided for in Chapter 58, Article 8, of the Code of Alabama of 1923.

And whereas, application has been made to the Auditor of the State by George Huddleston to purchase said lands, and said sum of One Hundred & No/100 (\$100.00) Dollars therefor has been paid into the State Treasury.

Now therefore, I, W. B. Allgood, as Auditor of the State of Alabama, by virtue of and in accordance with the provisions of said Chapter 58, Article 8, of the Code of Alabama of 1923, with the approval of the Governor of Alabama, and in consideration of the premises above set out, have this day granted, bargamned, sold and conveyed and by these presents do grant, bargain, sell and convey unto the said George Huddleston without warranty or covenant of any kind on the part of the State express or implied, all right and title of the State of Alabama in and to said lands, described as follows:

NE $\frac{1}{4}$ of NE $\frac{1}{4}$, and W $\frac{1}{2}$ of NE $\frac{1}{4}$, and SE $\frac{1}{4}$ of NW $\frac{1}{4}$, Section 12, Towns Lip 19, Range 1 E, lying and being situate in said County and State, to have and to hold the same, the said right and title of the State in the lands aforesaid, unto George Huddleston and his heirs and assigns forever.
