Thompson for and in consideration of the sum of Fifteen & No/100 Dollars (\$15.00) to us in hand paid by Alabama Power Company a corporation the receipt whereof is acknowledged, do hereby grant, to said company, its successors and assigns, the right to construct, operate and maintain electric transmission lines and all telegraph and telephone lines, towers, poles and appliances necessary or convenient in connection therewith from time to time upon a strip of land one hundred feet in width, as said strip is now located by the final location survey thereof heretofore made by said Company, over and across the lands of which it is hereinafter described as being a part said survey to determine the boundaries of said strip, together with all rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut and keep clear all trees and undergrowth and other obstruction on said strip and danger trees adjacent thereto which now or may hereafter injure or endanger any of the works on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip.

Said strip is a part of a tract of land situated in Shelby County, Alabama, described as follows:

The northeast quarter of the southeast quarter of Section 22, Township 19 south Range 2 east, said strip is approximately described as follows: Fifty Feet on each side of a line and the continuations thereof; Begin at a point on the east boundary of said section 22, said point being north 1464.4 feet from the southeast corner of said Section 22; thence run north 23 degrees 27 minutes west 1282.8 feet more or less to north boundary of said northeast quarter of southeast quarter.

TO HAVE AND TO HOLD the same to the said Company, its successors and assigns forever. The grantors shall have the right to cultivate and use said strip of land for any purpose not inconsistent with the rights which the grantee may from time to time exercise hereunder.
