KNOW ALL MEN BY THESE PRESENTS, that I, Garland H. Ozley of said County and State, for and in consideration of the sum of Seven Hundred and Fifty (\$750.00) Dollars in hand paid to me by Atchison Lumber Company, a corporation, the receipt whereof is hereby acknowledged, do bargain, sell and convey unto the said Atchison Lumber Company a corporation, all of the timber of every character whatsoever now standing upon the following real estate to-wit:

North half of northeast quarter and north half of northwest quarter of Section 34, Township 20, Range 2 west, in Shelby County, Alabama, which measures eight inches and upward at the butt of said trees.

The above conveyance however is intended and only conveys the right that said timber be cut and removed at any time within two years from the date of the execution of this instrument. After the expiration of said time the title to all of said timber which may be on said above described premises shall revert back to the grantor herein named.

It is understood and agreed and made a part of the consideration of this instrument that the said Atchison Lumber Company, a corporation, may erect and operate on said premises saw mills necessary, convenient or useful in and about the cutting and manufacturing of said timber into lumber on the above described premises.

It is further understood that the said Atchison Lumber Company shall have the right of egress and ingress over, across and through said above described premises for the purpose of transporting timber, lumber and all purposes necessary or useful in and about cutting and manufacturing said timber on said premises into lumber.

It is further understood and agreed that the said Atchison Lumber Company, a corporation, shall have the right to remove any building constructed on said premises after the termination of said right to cut said timber above described as provided in this instrument.

To have and to hold the same unto the said Atchison Lumber Company, a corporation, its successors and assigns.
