

Beginning at the SW corner of McGraw's lot north 32° 21° west 275 feet to a stake, thence E. 0° 58° west 278-4/10 feet to a stake, thence N. 86° 32° west 195 feet to a point in the Elliott Road, thence E.down said road 2° 38° east 120 feet to a point in edge of road. Then south 3° 38 east 472 feet, thence W 3° 19° west 426-1/10 feet to point of beginning, containing 3-1/10 acres more or less, and laying and being in ME of NE Sec. 15, T. 19, 2 E, all in Shelby County Alabama.
