KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of One Hundred DOLLARS, to the undersigned Grantor *J. D. Owen*, a single man, in hand paid by *J. T. Leeper*, the receipt whereof is hereby acknowledged, *cl* the said *J. D. Owen*, do grant, bargain, sell and convey unto the said *J. T. Leeper*, the following described Real Estate, to-wit:

The north-west quarter of north-west quarter fractional section 22, Township 22, Range I east; And also that part of south-west fraction of said section 22 lying within the following boundaries to-wit: Commencing at the SW corner of said NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of fractional section 22, running south along section line across Spring Creek and up to the top of a rocky ridge; thence in a north-easterly direction along on the top of said rocky ridge to the line running of south from the NE corner of the above described NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of fractional section 22; thence north along said line to the East bank of said creek to the south boundary line of the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of said fractional section; thence west to starting point.
