Personally appeared before me the undersigned authority in and for said State and County, J. O. Crumley, who, being by me duly sworm, deposes and says as follows:

My name is J. O. Crumley and $^{
m I}$ am one of the grantees in that certain deed from J. M. C. Johnson and Theo. W. Johnson to J. O. Crumley and E. A. Edwards, dated December 31, 1919. At a later date E. A. Edwards and myself had a division of the property bought from J.M. C. Johnson and Theo W. Johnson and on February 5, 1927, I quit claimed certain property to E. A. Edwards and on the same date he quit claimed certain property to me which includes the following property: SEE of MEE, Sec. 5, Range 2 west, that part of NW_{4} of NW_{4} of Sec. 4, T_{p} . 20, Range 2 west beginning 10 rods west from the SE corner of said forty; thence north to the Township line dividing 19 and 20; thence west to corner of said forty; thence south tocorner or said forty; thence east to place of starting. Also that part of the W_2^+ of SW_4^- of Sec. 33, Tp. 19, Range 2 west described as beginning 10 rods west of the northwest corner of said eighty; thence south to the Southerly boundary line of said eighty; thence west to the southwest corner of said eighty; thence north to the northwest corner of said eighty; thence east to the place of starting, which description should start as beginning 10 rods west from the northeast corner of said eighty instead of 10 rods west from the northwest corner of said eighty; Also that part of the SE of the SE of Sec. 32, Tp. 19, Range 2 west, beginning at the NE corner of said forty running thence west 24 rods, thence in a southeasterly direction in a straight line to the southeast corner of said forty, thence north to the place of keginning. Also a part of the NE% of SE% described as follows: Beginning on the north line of said forty which runs east and west at a point near the NE corner hereof, where a lane running in a northerly and southernly direction runs into said line, running thence in a southerly direction runs into said line running thence in a southernly direction along the middle of said lane to the point where the same runs into or intersects the southernly boundary line of said forty running thence east to the SE corner of said forty running thence north to the NE corner of said forty running thence west to the point of beginning and being allthat part of said forty lying east of the middle of said lane and allof said land lying in Section 32, and 33, Tp. 19, Range 2 west.

I moved on it. It was all enclosed by a fence except the small part in the southern portion of the NW of NW of Sec. 4, of about 3 acres which are in the woods and the SEL of NEL of Sec. 5, and continuously lived on it, claiming to own it under our deed from J. M. C. Johnson and Theo W. Johnson for seven and one half years. I then moved to Birmingham and stayed about a year and a half and then moved back where I am still living on it. During the time that I stayed in Birmingham I had it cultivated and to my certain knowledge this land has been actually in the possession of J.M. C. Johnson and myself for more than twenty years preceding this date, and throughout this time no one has ever laid any claim to any part of this land. Upon buying this property in 1919 I assessed it on the tax book of Shelby County and have paid taxes on it continuously ever since.
