That he is 60 years of age and is the son of Isaac W. Johnson, who died in 1897, and that his only children who survived him were W. R. K. Johnson, W. T. Johnson, J. M. B. Johnson, I. E. N. Johnson, T. W. Johnson and this affiant; and all of the above named children executed conveyances of their interest in the lands belonging to Isaac W. Johnson at the date of his death to J. M. C. Johnson, this affiant and Theo W. Johnson who is one and the same as T. W. Johnson above mentiomed, the said Theo W. Johnson and J. M. C. Johnson, this affiant having purchased the interest of their brothers in their father's estate;

Further deposing, affiant says that he knows of his own personal knowledge that his father purchased the southwest quarter of southwest quarter of Section 34, Township 18 south of range 2 west, Jefferson County, Alabama, from J. V. Acton some years prior to his death and that he, said affiant has seen the deed that was executed to his father conveying this tract of land, and that his father and after his death his mother and after her death the said affiant and his brother Theo W. Johnson have been in the actual possession of said forty acres of land by either cultivating crops on said land themselves, or having tenants cultivate crops thereon during each crop year for the past forty years, or more; and his father, his mother, his brother Theo W.
