Township twenty two range three west. Containing 32-58/100 Ac. 20 ac of the South end of No. E $\frac{1}{2}$ of the So. E $\frac{1}{4}$ 10-50/100 Ac. off of the South end of the No. W E $\frac{1}{4}$ of So. E $\frac{1}{4}$ 4.35/100 off of the South end of the No. E $\frac{1}{4}$ of So. W E $\frac{1}{4}$ all in Section 8, township 22 of Range 3 We. All lying and being in the Tuscaloosa land district, to have and to hold the said land unto W.H.
