

## DECREE.

The State Of Alabama,)  
 Shelby County.)  
 Millie McGinnis,)

This cause coming on to be heard on this the 14th. day of September, 1921, was submitted upon the Bill of Complaint, Decree Pro Confesso on Publication, and testimony as noted by the Register, and upon consideration thereof, the Court is of the opinion that the Complainant is entitled to the relief prayed for in her said bill;

It is therefore, ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the Complainant and Respondent, be, and the same are, hereby dissolved, and the said Millie McGinnis is forever divorced from the said Ed J. McGinnis for and on account of voluntarily abandonment.

It is further ordered, adjudged and decreed by the Court that neither party to this cause shall again marry, except to each other, until sixty days after the rendition of this decree, and that if an appeal is taken within sixty days, neither party shall marry, except to each other, during the pendency of such appeal.

It is further ordered by the Court that the Lot described in the bill of complaint, as one vacant lot in the town of Jacksonville Montevallo, Alabama, owned by the said Millie McGinnis and Ed J. McGinnis, jointly, and conveyed by Nero Brasher and wife Mary Brasher to them, the said Millie McGinnis and Ed J. McGinnis, on the 7th. day of March, 1904, as shown by a copy of said decree attached to said bill of complaint, was at the time of said voluntary abandonment by the said Ed J. McGinnis being held and occupied by complainant and respondent as a homestead, be and the same is hereby decreed as the property of complainant, Millie McGinnis, as to the half interest owned by Respondent, and complainant is hereby decreed said half interest as alimony decreed her as expenses to conduct this suit, and for permanent alimony.

It is further ordered that Millie McGinnis pay the costs herein taxed, for which execution may issue.

It is further ordered that Millie McGinnis be permitted to again contract marriage after sixty days from rendition of this decree, if there be no appeal from same, upon the payment of the costs of this suit.
