

AFFIDAVIT

Before me the undersigned authority in and for said State and County, personally appeared J. T. Crenshaw who being by me first duly sworn deposes and says: that his name is John Thomas Crenshaw, and is commonly known as Thomas Crenshaw; that he is 43 years of age and that he has been a resident of Shelby County, Alabama, for 43 years; that he is acquainted with the following described lands to-wit: The $N\frac{1}{2}$ of $NW\frac{1}{4}$ of Section 24; and the $N\frac{1}{2}$ of $NW\frac{1}{4}$ of $SE\frac{1}{4}$ and two acres in the SW corner of the $SE\frac{1}{4}$ of $NE\frac{1}{4}$ of Section 24; all in Township 20, Range 1 west; that he is well acquainted with the lands that W. N. Poe bought from Berry Hughes, and that W. N. Poe in turn gave a deed to M. Allen and Allen in turn executed a mortgage to W. N. Poe; that the lands in fact bought and in possession by said W. N. Poe and by said M. Allen is described as follows: The $N\frac{1}{2}$ of $NW\frac{1}{4}$ of $SE\frac{1}{4}$ and two acres in the SW corner of the $SE\frac{1}{4}$ of $NE\frac{1}{4}$ of Section 24, Township 20, Range 1 west, and not the $N\frac{1}{2}$ of $NW\frac{1}{4}$ and 2 acres in the SW corner of the $SE\frac{1}{4}$ of $NE\frac{1}{4}$ of Section 24, Township 20, Range 1 west, as described in that certain mortgage, recorded in Mortgage Book 122, on page 579, from M. Allen to W. N. Poe; that neither of the last named parties, have ever been in possession or claimed to own the said $N\frac{1}{2}$ of $NW\frac{1}{4}$ of said Section 24; but were in possession and claimed to own the above described 22 acres; that affiant is now the owner and the party in possession of the $N\frac{1}{2}$ of $NW\frac{1}{4}$ of $SE\frac{1}{4}$ and 2 acres in the SW corner of the $SE\frac{1}{4}$ of $NE\frac{1}{4}$ of Section 24, Township 20, Range 1 west, which is the M. Allen lands; that affiant has resided near this land all of his life and is well acquainted with all the lines of the lands in this neighborhood and the owners thereof; that he has not interest whatsoever in the $N\frac{1}{2}$ of $NW\frac{1}{4}$ of Section 24, Township 20, Range 1 west, in Shelby County, Alabama.
