And Whereas, application has been made to the Auditor of the State by Paul O. Luck & R. Brewer to purchase said lands, and said sum of Eleven & 52/I00 (\$II.52) Dollars therefor has been paid into the State Treasury.

Now Therefore, I, S.H. Blan, as Auditor of the State of Alabama, by virtue of and in accordance with the provisions of said Chapter 58, Article 8, of the Code of Alabama of 1923, with the approval of the Governor of Alabama, and in consideration of the premises above set out, have this day granted, bargained, sold; and conveyed, and by these presents do grant, bargain, sell, and convey unto the said Paul O. Luck & R. Brewer, without warranty or covenant of any kind on the part of the State, express or implied, all right and title of the State of Alabama in and to said lands, described as follows:

NW of NE , Section 26, Township 2I, Range 2W. lying and being situate in said County and State, to have and to hold the same, the said right and title of the State in the lands aforesaid, unto Paul O.
