RIGHT OF WAY DEED FOR PUBLIC ROAD

County and State aforesaid, in and for the consideration of Fifty Dollars in hand paid by Shelty County the receipt whereof is hereby acknowledged and for the further consideration of the benefits accruing to us and to the public from the construction of a public road through our lands, we do hereby give, grant, bargain, sell and convey unto helty County, its successors or assigns a right of way hereinafter described over and across the lands of the undersigned for a public road, which right of way shall be 66 feet in width or 33 feet in width on each side of the center line of the said road, as it is now located and staked out by the State Highway Department, or as much of ourlands as is required to make a foot right of way across our lands which are located and described as follows to-wit:

An irregular shaped strip of land 66 ft. wide, located 33 ft. on each side of center line of State Highway 44-B, Shelty County, Alabama; as staked and located by the State Highway spartment of Alabama, said strip of land being more fully described as follows, beginning at a point which is Station 235 / 18 on center line of said road, thence easterly a distance of 47 ft. to a point, thence northwesterly along a line which is 33 ft. north of and parallel to said center line for a distance of 258 ft. to a point, thence south 94 ft. to a point; thence southeasterly along a line which is 33 ft. south of and parallel to said center line a distance of 126 ft. to a point, thence east 47 ft. to the point of beginning, Said strip of land being located in NW4 of the NW2 of Sec. 5, T. 22 S R. 1 W Shelty County Alabama, containing 0.2909 acres more or less, and for and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospecive to our property, arising out of the construction, maintenance or repair of said road and thatsaid road is a benefit to our property is hereby admitted and acknowledged.
