

RIGHT OF WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS that we the undersigned W. M. Polk and wife Sarah Polk of the County and State aforesaid, in and for the consideration of One Dollars (\$1.00) in hand paid by Shelby County, the receipt whereof is hereby acknowledged, and for the further consideration of the benefits accruing to us and to the public from the construction of a public road through our lands, we do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right of way hereinafter described, over and across the lands of the undersigned for a public road; which right of way shall be ___ feet in width or ___ feet in width on each side of the center line of the said road, as it is now located and staked out by the State Highway Department or as much of our lands as is required to make a ___ foot right of way, across our lands which are located and described as follows, to-wit:

Beginning at Sta. 110 / 95 of State Project S-44-B and continuing in a south-westerly direction along the CL of said Project a distance of 5 feet to Sta. 111 / 00.

Said strip of land being 40 feet in width along the northerly side of said CL, and lying and being in the SE 1/4 of the NW 1/4 of Sec. 34; Twp. 21, R. 1 W, Shelby County. and for and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospective to our property, arising out of the construction, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
