RIGHT OF WAY DEED FOR PUBLIC ROAD

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned M. L. German a widow, of the County and State aforesaid, in and for the consideration of Five Hundred "ollars in hand paid by Shelby County, the receipt whereof is hereby acknowledged, and for the further consideration of the benefits accruing to us and to the public from the construction of a public road through our lands, we do hereby give, grant, targain, sell and convey unto Shelty County its successors or assigns a right of way hereinafter described, over and across the lands of the undersigned for a public road which right of way shall be 66 feet in width or 33 feet in width on each side of the center line of the said road, as it is now located and staked out by the State Highway "epartment or as much of our lands as is required to make a 66 foot right of way, across our lands which arelocated and described as follows to-wit:

Beginning at Sta. 13 / 15 of State Project 44-B; and continuing in a southwesterly direction along the center line of said Project a distance of 3915 feet to Sta. 52 / 30. Said strip of land being 33 feet wide along the northerly side of said center line between Stations 13 \neq 15 and 25 \neq 50 a distance of 1235 feet; and being 66 feet in width, 33 feet in width along each side of said center line between Stations 25 \neq 50 and 52 \neq 30 a distance of 2680 feet. Also the following land for a borrow-pit, viz: Beginning at a point 33 feet south of and at right angles to Sta. 25 \neq 00 on center line of said Project, thence southwesterly a distance of 460 feet along the south edge of right of way herein granted, thence south 124 feet to center of present road, then ce northeasterly along center of present road to intersection between center of present road and south edge of right of way herein granted, and for and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospective to our property, arising out of the construction, maintenance or repair of said road, and that said road is a tenefit to ourproperty is hereby admitted and a cknowledged.
