I am acquainted with the NE $\frac{1}{4}$ of the SE $\frac{1}{4}$ and ten acres on the south side of SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 20, Township 19, Range 2 west, in Shelby County, Alabama.

I have known said land and have been intimately acquainted with said land and the various owners there of for the last 30 years. I know of my own knowledge that Isaac N.Gilbert was in possession of said land under claim of ownership and claiming to own said land in the year 1893, when he purchased said land from James A. Acton and wife and was put in possession of said land, and that he continued in possession of saidland until he died intestate about the year 1911. All debts owing by deceased have been paid, and there are no debts owing by said deceased chargeable against saidland. Said Isaac N.Gilbert at the time of his death left surviving him the following heirs and none others, as follows; his widow, Mrs. N. E. Gilbert, who was one and the same person as Nancy E. Acton, a daughter of James W. and Jane Acton; A. C.Gilbert, whose wife was E. L.Gilbert; Ida P. Lacey whose husband is P.B. Lacey; Ophelia Gardner; whose husband is J. A.Gardner; Lula Rutherford, whose husband is G. W. Rutherford. I am a daughter of said Isaac N.Gilbert. I knew and was acquainted with the \mathbb{W}_2^1 of the $\mathbb{N}\mathbb{W}_4^1$ of the $\mathbb{S}\mathbb{W}_4^1$ of \mathbb{S} 21, Township 19, Range 2 west when said land was in the possession of Jane Acton, and who continued in possession, under claim of ownership, until she died intestate in 1902. In 1907, after the death of said Jane Acton, R.M. Acton, who was one and the same person as Rufus M. Acton, and A. J. Acton, both of whom were sons of Jane Acton and James W. Acton, both of whom were then dead, sold and conveyed their interest in said land to Isaac N. Gilbert, the other undivided interest at that time being owned by Nancy E. Gilbert, the wife of Isaac N.Gilbert.

From 1907 until the present time, all of said land has been in the possession of Isaac N.Gilbert and his wife Nancy E. Gilbert, and their heirs, and to the exclusion of all other persons. Said possession has been continuous. Part of said time said land has been cultivated and during all of said time said land has been used by said persons as their own, as pasture and woodland and said persons have assessed and paid taxes on said land, under claim of ownership and during all of said years Alden N. Byram, nor any other person, has been in possession of said land, nor claimed to own the same, other than the said heirs of Isaac N. Gilbert and their predecessors in title as aforesaid.
