Collum the receipt whereof is hereby acknowledged we do remise, release, quit claim and convey to the said L.C.Collum all our right, title, interest and claim in or to the following described real estate to-wit: Five acres of land off of the NE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 7, Township 20, south Range 2 west, described as follows: Commencing at the southwest corner of E.C.Collin's land, running south 110 yards, thence east 220 yards, thence north 110 yards, thence west 220 yards to point of beginning, following east west line of E. C. Collin's land and lying south of E.C. Collin's land containing five acres more or less; also a part of the NE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 7, Township 20, Range 2 west, described as follows: Beginning at the NW corner of the said above described forty thence running 200 yards south, thence east 110 yards, thence north 220 yards, thence west 110 yards to beginning point, containing five acres more or less, situated in Shelby County, Alabama.
