

LINE PERMIT

We, Frank Frost and wife Willie Frost for and in consideration of the sum of One Dollar (\$1.00) to us in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith, as located by the final location survey heretofore made by said Company, for the transmission of electric power with the right to string thereon from time to time electric power and telephone wires upon, over and across the following described land situated in Shelby County Alabama;

Lot in the Village of Dogwood, containing one acre, more or less, and known as the Isaac Powell Lot, said lot being located in southeast quarter of the northeast quarter of Section 5, Township 22, Range 3 west, said lot of land being bounded as follows; on the north by the Striplin place, on the east by the Methodist Church land, on the south by Heath place, and on the west by right of way of Southern Railway company, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said company, its successors and assigns forever.
