

## LINE PERMIT

STATE OF ALABAMA )

KNOWALL MEN BY THESE PRESENTS, that the undersigned Little Gem coal Company, a corporation for and in consideration of the sum of One Dollar (\$1.00) to it in hand paid by Alabama Power Company, a corporation, the receipt whereof is acknowledged, does hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain its lines of poles and towers and appliances necessary in connection therewith as located by the final location survey heretofore made by said Alabama Power Company, for the transmission of electric power, with the right to string thereon from time to time electric power and telephone wires upon, over and across the following described land situated in Shelby County, Alabama:

The village of the Little Gem Coal Company's mine situated in Section 5, Township 22, Range 3 west. It is understood that said lines are to be constructed at location agreed upon with Mr. Sam John, Superintendent of the Little Gem Coal Company, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees that may injure or endanger said lines.

TO HAVE AND TO HOLD the same to the said Alabama Power Company, its successors and assigns forever.

In witness whereof the said Little Gem Coal Company, has caused this instrument to be executed in its name by J. Molton Smith as its President, and attested by O. M. Cross, Assistant Secretary, and its corporate seal to be hereto affixed, on this the 21st. day of November, 1928.
