

Right Of Way Deed.

Know All Men By These Presents: That we, the undersigned, Charley T. Hughes and wife Montie Hughes of the County and State aforesaid, in and for the consideration of one dollar (\$1.00) in hand paid by Shelby County, the receipt whereof is hereby acknowledged, and for the further consideration of the benefits accruing to us and to the public from the construction of a public road through our lands, we do hereby given, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a right of way hereinafter described, over and across the lands of the undersigned in Shelby County, Ala., for a public road; Which right of way shall be 66 feet in width or 33 feet in width on each side of the center line of the said road, as it is now located and staked out by the State Highway Department, or as much of our lands as is required to make a 66 foot right of way, across our lands which are located and described as follows, towit:

A strip of land 33' in width lying wholly on the South side of center line of State Proj. 330 beginning at Sta. 325 / II and continuing in an easterly direction along center line of said survey for a distance of 316' to Sta. 328 / 27 where said strip of land becomes 66' in width lying 33' on each side of said center line of said survey for a distance of 833' to Sta. 336 / 60. and for and in consideration of the benefit to our property by reason of the construction of said road, we hereby release the county from all consequential damages, present or prospective to our property, arising out of the construction, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged.
