Burnett and wife Alma Burnett do grant, bargain, sell and convey unto the said Dave Woolly the following described Real Estate, to-wit:

Beginning at a point 260 feet south of the northwest corner of lot 15, block 2, as shown on map J.E. Bosman, run thence south 566 feet and 8 inches to the southwest corner of lot 16; thence east to Montevallo dirt road, thence along said road to an iron stake, thence west 1100 feet to the point of beginning, the same containing in all 8 acres more or less, and being
