The northwest quarter of northwest quarter of Section 11, township 20 So. Range 3 west. Together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including the right of ingress and egress to and from said lines; and also the right to cut and keep clear all trees that may injure or endanger said lines .
