One lot or parcel of land in the Town of Calera, Alabama, commencing at a point on the north side of the Southern Railway 35 feet from the center of the main track of said road and ten inches west of the southwest corner of building known as the Wade & Hill two story brick building, which building is located on the lot herein conveyed in this instant, thence in a north westerly direction along the line of said wall to a point 65 feet south of the L and N (Y) track, at right angles with the track meandering from center of (Y) track thence in a south westerly direction parallel with said (Y) track 18 and 2/3 feet more or less to the west line, thence in a southeasterly direction to the point of beginning; situated, lying and being in the County of Shelby and State of Alabama.

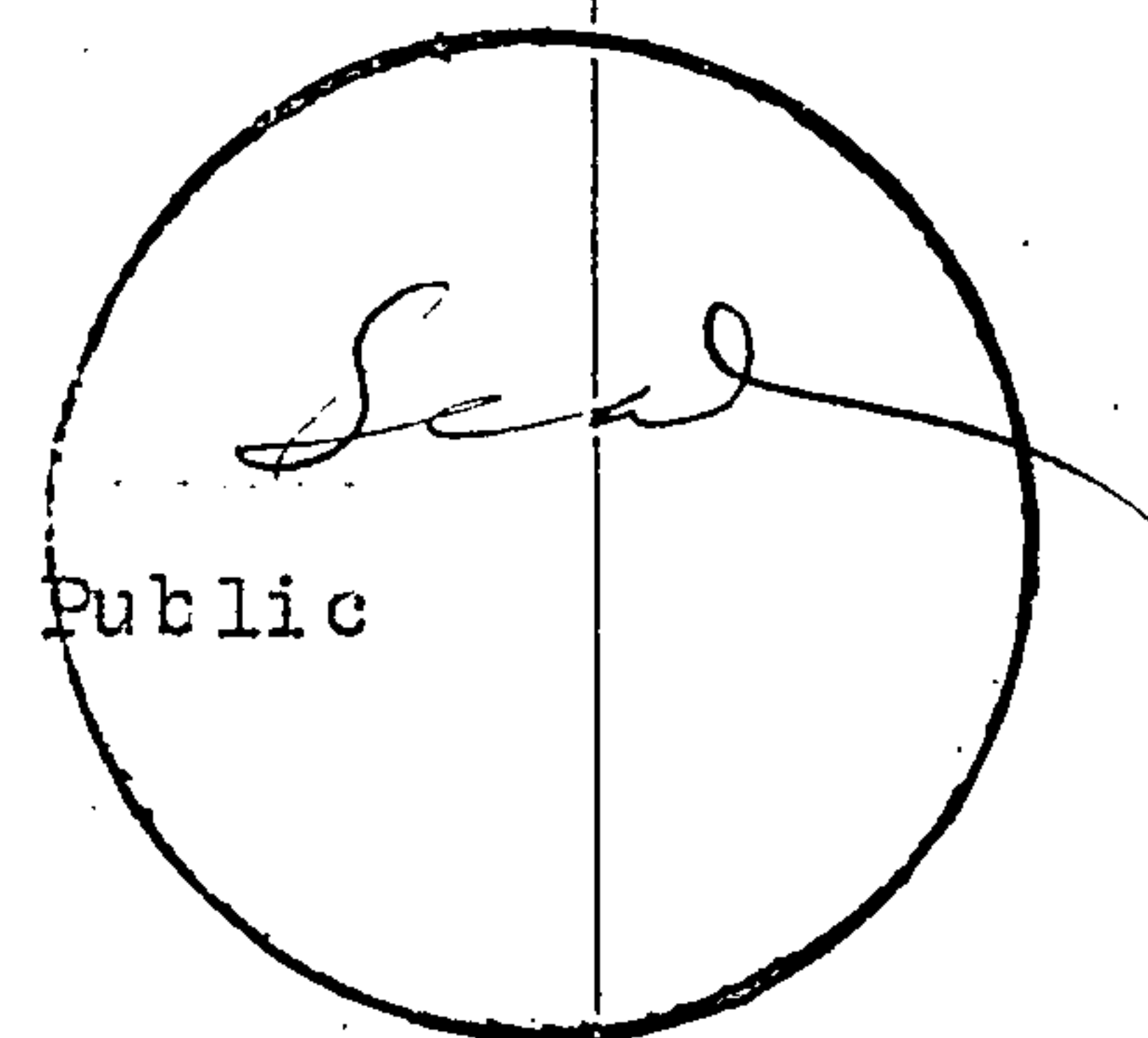
