KNOW ALL MEN BY THESE PRESENTS, That John Greenlea and wife Etta Greenlea
for and in consideration of Two Hundred and Fifty (\$250.00) DOLLARS,
to us paid in hand by T. R. Walton the receipt whereof is hereby acknowledged,
do grant, bargain, sell, and convey unto the said T. R. Walton
the following described property—to wit:

All the pine timber, eight inches and up at the butt on the following described lands
to-wit:

The west half of the southwest quarter of Section 2, Township 22, Range 1 west,
and the northwest quarter of the northwest quarter of Section 11, Township 22, Range 1
west,

It is further agreed by and between the grantors and the grantees herein that the
above described timber is to be cut and removed from said land within eighteen months
from the date of this deed, and on and after said eighteen months, all timber remaining
on said lands, together with all interest conveyed herein, shall revert and become the
property of the grantors herein named

situated, lying and being in the County of Shelby and State of Alabama.

TO HAVE AND TO HOLD the same unto the said T. R. Walton
his heirs and assigns, forever. And we do, for ourselves and our heirs, executors, and administrators, covenant with
the said T. R. Walton, his heirs and assigns, that we lawfully seized in
fee-simple of said premises; that they are free from all incumbrances; that we have a good right to sell and convey the said property; that we will, and
our heirs, executors, and administrators shall warrant and defend the same to said T. R. Walton
his heirs, executors, and assigns, forever, against the lawful claims of all persons whomsoever. as to said timber.
