The purpose of this conveyance being to release said premises from the lien of said mortgage.

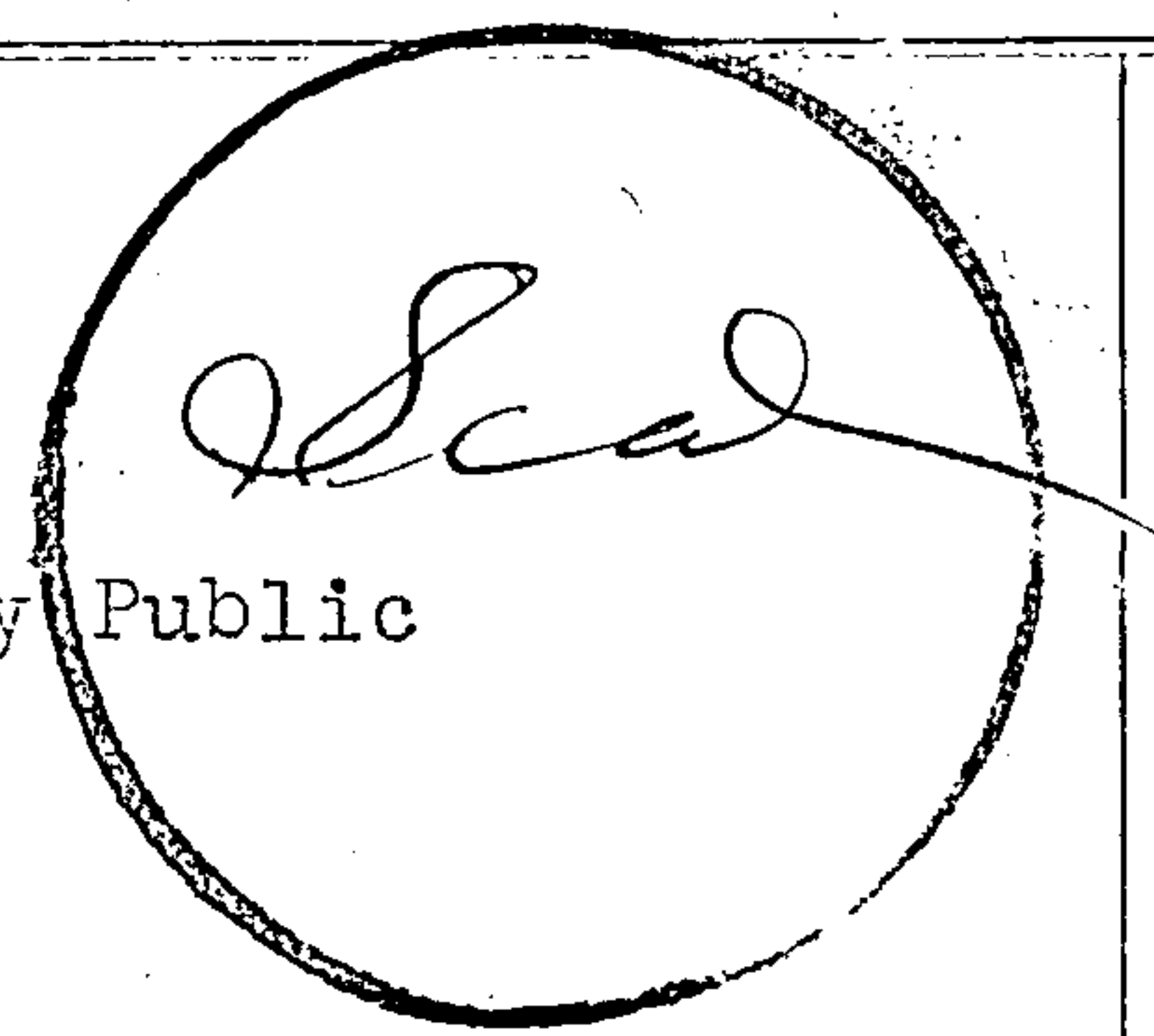
