TO HAVE AND TO HOLD the above described real estate and all and singular the tenements and appurtenances thereto belonging or in any wise appertaining, to the said A. J. Gray, his heirs and assigns in fee simple forever, except parties of the first part reserve for a period of eighteen months, from June 18, 1929. all merchantable timber 8" and up at stump. And the parties of the first part do and their heirs and administrators shall warrant and forever defend the title to the above described and hereby granted premises to the said party of the second part, his heirs and assigns from and against the lawful title, claim or demand of any and all persons whomsoever.
