Before me, the undersigned authority in and for said County in said State, personally appeared J.R. Beavers and E.H. Wilder who being duly sworn deposes and says, on oath, that they knew C.F. Elliott; that said C.F. Elliott died prior to January 14th, 1915, leaving as his ownly heirs and next of kin, his son T.C.E, liott and the following sons and daughters who are mentioned as grantors in a certain conveyance to said T.C.Elliott of date January 14th 1915, to-wit: R. W.Elliott, C. M.Elliott, S.E.Elliott, whose wife was Lida M.Enliott (orL. M. Enliott); Pauline Armstrong, whose husband was B.S. Armstrong; W.J.Elliott, whose wife was Josie Elliott; W.B. Elliott, whose wife was Bertha Elliott; L. C.Elliott, and Mrs.L. C. Montgomery, who was a widow at said time, all of whom were of full age at the date of said deed; Affiant further says that the said C.F. Elliott at the time of his death owned the said property mentioned in said deed, except about six acres the reof that he had there to fore sold and conveyed to Fannie S.Elliott, who was the wife of T.C.E, liott; and that his said heirs mentioned in said deed owned same at the date of the said conveyance; that since the date of said conveyance, to-wit: January 14, 1915 the said T.C. Elliott and wife F.S. Elliott have been in the actual, open, notorious, disible, hostile, continuous possession of said property under claim of right and ownership, up to December 16th, 1918, when they conveyed said property to Luther M. Davis who has so held such possession of saidproperty adversely, until he sold and conveyed the same to E.H.Wilder, on, to-wit: November 2nd, 1927; and that the said E.H.Wilder has so held suchadverse possession of said property fromsaid date until the present time; Affiant further says that during allthe time he has known the said property, which is fully twenty years, its boundaries have been well fixed and marked byfences and enclosures, and that the following is a correct description of the said property, from a careful survey thereof, and is the identical property mentioned in said conveyance of said heirs to T. C. E, liott of date January 14th 1915, to-wit:
