## RIGHT OF WAY DEED

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned H.T.Dickens, Mayor of Town of Wilsonville, A. a. of the County and State aforesaid, in and for the consideration of One Collar (\$1.00) in hand paid by \_\_\_\_\_County, the receipt whereof is hereby acknowledged, and for the further consideration of the benefits accruing to us and to the public from the construction of a public road through our lands we do hereby give, grant, bargain, selland convey unto Shelby County, its successors or assigns, a right of way hereinafter described over and across the lands of the undersigned in Shelby County, Ala. for a public road, which right of way shall be 66 feet in width one achside of the center line of the said road, as it is now located and staked out by the State HighwayDepartment, or as much of our lands as in required to make a 33 foot right of way, across our lands which are located and described as follows to-wit:

A strip of land 33 feet wide lying on the left of the center line beginning at Station 490 plus 64 and running along said center line in a northeasterly direction to Station 492 plus 06, and for and in consideration of the benefit to our property by reason of the construction of said road, we herebyrelease the county from all consequential damages, present or prospective to our property arising out of the construction, maintenance or repair of said road and that said road is a benefit to our property is hereby admitted and acknowledged.
