Before me Jno. B.Rosenstihl, a Notary Public in and for said County in said
State, personally appeared Ellen Dawson, who is known to me, and who being by me
duly sworn according to law, deposes and says that she is a daughter of Benjamin F.
Harris, who died in the year 1883, and who at the time of his death owned a tract
of land which is now known as the "Harris Estate Lands", situated partly in the
southeast quarter and the southeast quarter of the northeast quarter of section 29
and partly in the west half of the southwest quarter of section 28, in Township 18
south, range 1 west, in Shelby County, Alabama; that affiant has known and is
familiar with all of the descendants of said Benjamin F.Harris; that the said Benjamin
F. Harris died intestate, his wife being also dead; and that the following constitute
all of his heirs at law;

- (1) The first child of Benjamin F. Harris was Mary Anne Harris McLaughlin, who married M. W. McLaughlin both of whom are now dead; having died intestate. The following are her only heirs at law;
- I. George B. McLaughlin a son, who is now dead, having died intestate, and whose wife is also dead. He left surviving him two children as his sole heirs at law;
- (1) Bert McLaughlin a son who is now living and who is unmarried.
- (2) M. E. McLaughlin a son, whose wife is named Josie McLaughlin, both of whom are now living.
- 2. Leona McLaughlin (who is the same person as Z. L. McLaughlin) a daughter who is unmarried and who is now living,
- 3. Sidney J.McLaughlin, a son, who is now dead, having died, intestate, but whose widow, Mary I. McLaughlin, is now living. He left surviving him the following five children as his sole heirs at law;
- (1) Mrs.Alice Ingram, a daughter, whose husband is named Robert D. Ingram, both of whom are now living.
- (2) Loraine McLaughlin a daughter who is unmarried and who is now living.
- (3) E. L. McLaughlin a son, whose wife is named Mignon McLaughlin both of whom are living.
- (4) R. L. McLaughlin, a son, whose wife is named Frances McLaughlin, both of whom are now living.
- (5) Gypsie M. Godwin, whose husband is named R.E.Goodwin, both of whom are now living.
- 4. Etta McLaughlin (who is also known as M.E. McLaughlin) a daughter, who is unmarried and who is now living.
- 5. J. B. McLaughlin, a son, who is unmarried and who is now living.
- (2) The second child of Benjamin F. Harris was Jane Harris, a daughter, who died intestate about the year 1894, unmarried, never having had any children,
- (3) The third child of Benjamin F. Harris was Overton C. Harris who is now dead, his wife being also dead. He moved to Texas while a young man and died intestate there, leaving surviving him eight children as his sole heirs at law, all of whom are now living. Affiant does not know the names of the respective husbands and wives of the said children but their names are as follows:
- 1. Mrsy Mary Ward, a daughter;
- 2. J. B. Harris, a son;
- 3. Paul Harris, a son;
- 4. G. W. Harris, a son; 5. C. C. Harris, a son;

- 6. Mrs. Anna Bailey, a daughter;
- 7. Mrs. Julia White, a daughter;
- 3. Mrs. Mattie Coates, a daughter;
- (4) The fourth child of Benjamin F. Harris was Ben J. Harris, a son who died intestate prior to the year 1892, unmarried, never having had any children.
- (5) The fifth child of Benjamin F. Harris, was William Yancey Harris, a son, who died intestate in 1863. He was killed at the battle of Lookout Mountain during the war between the States; never having married and never having had any children.
- (6) The sixth child of Benjamin F. Harris was Mariah Elizabeth Acton, a daughter, whose husband was Dr. W. M. M. Acton, both she and her husband having died intestate leaving surviving one child as her sole heir at law:
- 1. Maude Lee, a daughter, whose husband is named W.N.Lee, both of whom are now living.
- (7) The seventh child of Benjamin F. Harris was Ellen Dawson, the affiant, (who is the same person as Rachele E.Dawson) whose husband was B.F.Dawson, her husband having died about the year 1917, intestate, leaving surviving him his said widow, the affiant, and the following three children as his sole heirs at law;
- 1. Florence Lee, whose husband is Clyde Lee, both of whom are now living.

Harris (who was also known as Sam Harris and likewise as Samp Harris) who died intestate about six or eight years ago, leaving no descendants surviving him, being a widower at the time of his death, his wife having died prior to the date of his death.

Benjamin F. Harris as set out above who is now living is of sound mind and over the age of twenty one years, and that the said Bajamin F. Harris left surviving him no children or any descendants of a deceased child other than those hereinabove named.
