## PIPE LINE PERMIT

know all men by these pesents, that I, F.C.Cheney & wife hereinafter referred to as seller, for and in consideration of the sum of one Dollar (\$1.00) and other good and valuble considerations, the receipt whereof being hereby acknowledged, do hereby grant, unto the Southern Natural Gas Corporation, hereinafter referred to as purchaser, a right of way to lay, construct, maintain and operage a pipe line or lines, consisting of one or more pipes, and appurtenances thereto, including telephone or telegraph lines in connection therewith, and the free right of ingress and egress to and fromsaid right of way for the purpose of laying constructing, maintaining, repairing, replacing, operating or removing at will said pipe line and said appurtenances thereto, across the following described land situated in Shelby County, Alabama;

West half  $(W_{\mathbb{Z}}^1)$  of southwest quarter  $(SW_{\mathbb{Z}}^1)$  of section thirteen (13),  $T_0$  whip twenty one, (21) south, range three (3) west, being the same land acquired and more fully described as per deed of record in book 71 page 517 of the records of Shelby County Ajabama.

To have and to hold the same together with allthe rights and privileges necessary or convenient for the full enjoyment or use thereof including all rights of ingress and egress as above set forth, and the right to cut and keep clear all trees that may injure or endanger said lines unto the said purchaser, its successors and assigns, forever; provided, that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes herein stated, then the easements hereingranted and all rights incident thereto shall terminate. Provided further, that the seller especially reserves the use and enjoyment of the premises herein described, subject only to the exercise of the rights and privileges hereingranted to the purchaser.

It is understood and agreed that purchaser shall lay said pipe line below plow depth wherever it crosses any land that may be cleared and in cultivation and shall also lay said pipe line below plow depth across any land that may in the future be cleared and put in cultivation.

The location of said right of way on the above described land shall be determined by the puchaser, but said pipe line shall not be laid nearer than feet to any barnm residence or tenant house on said lands without writtenconsent of the seller.

The purchaser shall pay all damages to fences, crops and timber whichmay be suffered by reason of installation, maintenance, operation or alteration of said pipe line and appurtenances thereto. If not mutually agreed upon, said damages are to be ascertained and determined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by the grantee, and the third by the two so appointed as aforesaid, and the award of two of such three persons shallbe final and conclusive.
