KNOW ALL MEN BY THESE PRESENTS' that I (we), W.A.Fulton and wife Belle J.Fulton hereinafter referred to as seller, for and in consideration of the sum of Fifty One Pollars (\$51.00) and other good and valuableconsiderations the receipt whereof being hereby acknowledged, do herebygrant, unto the Southern Natural Gas Corporation hereinafter referred to as purchaser, a right of way to lay, construct, maintain and operate a pipe line or lines, consisting of one or more pipes, and appurtenances thereto, including telephone or telegraph lines in connection therewith and the free right of ingress and egress to and fromsaid right of way for the purpose of laying, constructing, maintaining, repairing, replacing, operating or removing at will said pipe line and said appurtenances thereto, across the following described lands situated in Shelby County, Alabama;

East half ($\mathbb{E}^1_{\mathbb{Z}}$) of southwest quarter ($\mathbb{SW}^1_{\mathbb{Z}}$) southeast quarter ($\mathbb{SE}^1_{\mathbb{Z}}$) of northwest quarter ($\mathbb{NW}^1_{\mathbb{Z}}$) in Section thirteen(13), Township twenty one (21) south, Range three (3) west, being the same land acquired and more fully described as per deed of record 7 40 record in Book 59 page 491 of the records of Shelby \mathbb{C}_0 unty, \mathbb{A}_1 abama.

To have and to hold the same, together with a lithe rights and privileges necessary or convenient for the full enjoyment or use thereof, including allrights of ingress and egress as above set forth, and the right to cut and keepclear all trees that may injure or endanger said lines unto the said purchaser, its successors and assigns forever; provided, that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes herein stated, then the easements herein granted and allrights incident thereto shall terminate. Provided further, that the seller especially reserves the use and enjoyment of the premises herein described, subject only to the exercise of the rights and privileges herein granted to the purchaser.

It is unde stood and agreed that purchaser shall lay said pipe line below plow depth wherever it crosses any land that may be cleared and in cultivation and shall also lay said pipe line below plow depth across any land that may in the futute be cleared and put in cultivation,

The location of said right of way on the above described land shall be determined by the purchaser, but said pipe line shallnot be laid nearer than _____feet to an barn, residence or tenant house on said lands without written consent of the seller. The purchasers shall pay all damages to fences, crops and timber which may be suffered by reason of installation, maintenance, operation or alteration of said pipe line and appurtenancess. thereto. If not mutually agreed upon, said damages one are to be ascertained and determined by three disinterested persons, thereto to be appointed by the owner of the premises, one bythe grantee, and the third bythe two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive.
