McDonough, V.Pres. hereinafter referred to as seller for and in consideration of the sum of One & 00/100. Collars (\$1.00) and other good and valuable considerations, the receipt whereof being hereby acknowledged, do hereby grant unto the Southern Natural Gas Corporation, hereinafter referred to as purchaser, a right of way to lay, construct, maintain and operate a pipe line or lines, consisting of one or more pipes, and appurtenances thereto, including telephone or telegraph lines in con ection therewith, and the free right of ingress and egress to and from said right of way for the purpose of laying, constructing, maintaining repairing, replacing, operating or removing at will said pipe line and said appurtenances thereto, across the following described lands situated in Shelby County, Alabama;

Southeast quarter (SE $\frac{1}{4}$) of northeast quarter (NE $\frac{1}{4}$) of Section thirty twi (32) and also north half (N $\frac{1}{2}$) of section thirty three (33) all in Township twenty one (21) south, range two (2) west. As our interest may appear.

To have and tohold the same together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof including all rights of ingress and egress as above set forth, and the right to cut and keep clear all trees that may injure o endanger said lines unto the said purchaser, its successors and assigns forever; provided, that if the purhhaser, its successors or as igns, should permanently abandon the use of said right of way for all of the purposes herein stated, then the easements hereingranted and allrights incident thereto shall terminate. Provided further that the seller especially reserves the use and enhoyment of the premises hereindescribed, subject only to the exercise of the rights and privileges herein granted to the purchaser.

It is understood and agreed that purchaser shall la said pipe line below plow depth wherever it crosses any land that may be cleared and in cultivation and shall also laysaid pipe line below plow depth across any land that may in the future be cleared and put in cultivation.

The location of said right of way on the above described land shall be determined by the purchaser, but said pipe line shall not be laid nearer than 50 feet to any barn, residence or tenant house on said lands without writtenconsent of the seller.

The purchaser shall pay all damages tofences, crops and timber which may be suffered by reason of installation maintenance, operation or alteration of said pipe line and apurtenances thereto. If not lutually agreed upon, said damages are tobe ascertained and determined by three disinterested pe sons. If not mutually agreed upon, said damages are tobe ascertained and determined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by the grantee, and the third by the two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive.
