know all men by these presents, that I, J.W. Pittman and wife Lula F. Pittman hereinafter referred as seller, for and inconsideration of the sum of Eight & 75/100 Dollars (\$8.75) and other good and valuable considerations, the receipt whereof being hereby acknowledged, do hereby grant unto the Southern Natural Gas Gorporation hereinafter referred to as purchaser, a right of way to lay, construct, maintain and operate a pipe line or lines, consisting of one or more pipes, and appurtenances thereto, including telephone or telegraph lines in connection therewith, and the free right of ingress and egress to and fromsaid right of way for the purpose of laying, constructing, maintaining, repairing, replacing, operating or removing at willsaid pipe line and said appurtenances thereto, across the following described lands situated in Shelby County, Alabama; Northeast quarter (NE2) of southwest quarter (SU2) Section thirty four (34) Township twenty (20) Range three (3) west.

To have and to hols the same, together withallthe rights and privileges necessary or convenient for the full enjoyment or use thereof, including all rights of ingress and egress as above set forth, and the right to cut and keepclear alltrees that may injure or endanger said lines onto the said purchaser, its successors and assigns forever; provided, that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes herein stated, then the easements hereingranted and all rights incident thereto shall terminate. Provided further, that the seller especially reserves the use and enjoyment of the premises herein described, subject only to the exercise of the rights and privileges herein granted to the purchaser. It is understood and agreed that purchaser shall lay said pipe line below plow depth wherever it prosses any land that may be cleared and in cultivation, and shallalso lay said pipe line below plow depth across any land that may in the future be cleared

and put in cultivation.

The location pof said right of way on the above described land shall be determined by the purchaser, but said pipe line shall not be laid nearer than feet to any barn, residence or tenant house on said lands without written consent of the seller.

The purchaser shall pay all damages to fences, crops and timber which may be suffered by reason of installation, maintenance, operation or alteration of said pipe line and appurtenances thereto. If not mutually agreed upon said damages are to be ascertained and determined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by the grantee, and the third by the two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive.
