KNOW ALL MEN BY THESE PRESENTS, that I (we) United States Realty Corporation of Birmingham, Alabama hereinafter referred to as seller for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations, the receipt where of being hereby acknowledged do hereby grant unto the Southern Natural Gas Corporation, hereinafter referred to as purchaser, a right of way to lay, construct, maintain, and operate a pipe line or lines, consisting of one or more pipes, and appurtenances thereto, including telephone or telegraph lines in connection therewith, and the free right of ingress and egress to and fromsaid right of way for the purpose of laying, constructing, maintaining, repairing, replacing, operating or removing at will said pipe line and said appurtenances thereto, across the following described lands situated in Shelby County, A, abama;

Southeast quarter (SE $\frac{1}{4}$) of southeast quarter (SE $\frac{1}{4}$) of Section eighteen (18); northeast quarter (NE $\frac{1}{4}$) of northeast quarter (NE $\frac{1}{4}$) and southwest quarter (SN $\frac{1}{4}$) of northeast quarter (NE $\frac{1}{4}$) of Section nineteen (19) all inTownship twenty two (22) south, range two (2) west.

To have and to hold the same together with allthe rights and privileges necessary or convenient for the full enjoyment or use thereof, including all rights of ingress and egress as above set forth, and the right to cut and keep clear all trees that may injure or endanger said lines unto the said purchaser, its successors and assigns forever; provided, that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes hereinstated, then the easements hereingranted and all rights incident thereto shall terminate. Provided further, that the seller esepcially reserves the use and enjoyment of the premises herein described, subject only to the exercise of the rights and privileges hereingranted to the purchaser.

It is understood and agreed that purchaser shall lay said pipe line below plow depth wherever it crosses any land that may be cleared and in cultivation and shall also lay said pipe line below plow depth across any land that may in the future be cleared and put in cultivation.

The location of said right of way on the above described land shallbe determined by the purchaser, but said pipe line shallnot be laid nearer than 50 feet to any barn, residence or tenant house on said lands without written consent of the seller.

The purchaser shall pay all damages to fences, crops and timber which may be sufferedby reason of installation, maintenance or alteration of said pipe line and appurtenances thereto. If not mutually agreed upon, said damages are to be ascertained and determined by these disinterested persons, one person to be appointed by the owner of the premises, one bythe grantee, and the third bythe two so appointed as aforesaid, and the award of two of such three persons shall be final and conclusive.
