## PIPE LINE PERMIT

KNOW ALLMEN BY THESE PRESENTS, that I (we) Julia N.Thompson a widow, hereinafter referred to as seller, for and in onnsideration of the sum of Fifty Eight Pollars (\$58.00) and other good and valuable considerations, the receipt whereof being hereby acknowledged, do herebygrant unto the Southern Natural Gas Ogrporation, hereinafter referred to as urchaser, a right of way tolay, construct, maintain, and operate a pipe line or lines, consisting of one or more pipes, and appurtenances thereto, including telephone or telegraph lines in connection ther with, and the free right of ingress and egress to and fromsaid right of way for the purpose of laying, constructing, maintaining, repairing, replacing, operating or removing at will said pipe line and said appurtenances thereto, across the following described lands situated in Shelby County, Alabama;

Thirty (30) acres on west side of the southwest quarter ( $SW_{4}^{\frac{1}{2}}$ ) of southwest quarter ( $SW_{4}^{\frac{1}{2}}$ ) of Section two (2),  $T_{0}$ wnship twenty one (21), south, Range three (3) west. All of southeast quarter ( $SE_{4}^{\frac{1}{2}}$ ) of Sectionthree (3), and north half ( $N_{2}^{\frac{1}{2}}$ ) of north east quarter ( $NE_{4}^{\frac{1}{2}}$ ) of Section ten (10), township twenty one (21), south, Range three (3) west, being the same land acquired and more fully described as per deed of record in book 130 page 179 of the records of  $S_{h}$ elby County, Alabama.

It is specifically understood that no blasting is tobe done between Blue Spring Branch and the fence on the east side of the grantor's oat field.

To have and to old the same together with allthe rights and privileges necessary or convenient for the full enjoyment or use thereof, including allrights of ingress and egress as abofe set forth, and the right to cut and keep clear all trees that may injure or endanger said lines unto the said purchaser, its successors and assigns forever; provided, that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes herein stated, then the easements herein granted and all rights incident thereto shall terminate. Provided further, that the seller especially reserves the use and enjoyment of the premises herein described, subject only to the exercise of the rights and privileges hereingranted to the purchaser.

It is understood and agreed that purchaser shall ay said pipe line below plow depth wherever it crosses any land that may be cleared and in cultivation, and shallalso lay said pipe line below plow depth across any land that may in the future be cleared and put in cultivation.

The location of said right of way on the above described land shall be determined by the purchaser, but said pipe line shall not be laid nearer than feet to any barn, residence, or tenant house on said lands without written consent of the seller. The purchaser shall pay all damage to fences crops and timber which may be suffered by reason of installation maintenance, operation or alteration of said pipe line and appurtenances thereto. If not mutually agreed upon, said damages are to ascertained and determined by three disinterested persons, one thereof to be appointed by the owner of the premises, one by the grantee, and the third by the two so appointed as aforesaid, and the award of two of such three persons shallbe final and conclusive.


