CERTIFICATE OF INCORPORATION of Shades Valley Holding Company

TO THE HONORABLE J. P. Stiles, Judge of Probate in and for the County of Jefferson State of Alabama:

We, the undersigned, each of whom is over the age of twenty one years, desiring to become a body corporate and pursuant to the laws of the State of Alabama, for the purposes hereinafter stated and set forth, do hereby file with your Honor as Judge of said Court, this, our Certificate of Incorporation, in accordance with Chapter #274 of the Code of 1923 of the State of Alabama, and we hereby declare, set forth and certify as follows:

First: That the name of the said proposed corporation is Shades Valley Holding Company.

Second: That the purposes for which this corporation is formed are:

- (a) To purchase, hold, sell, improve, divide and subdivide, lease, sublease, mortgage or encumber real estate or other property, and to erect manage, care for, maintain extend and alter buildings thereon; to conduct, erect and improve houses, buildings, public or private roads, alleys, tramways, sewers, conduits and subways to make enter into, perform and carry out contracts for constructing, altering, decirating, maintaining, setting up and improving buildings of every sort and kind, and to borrow, lend or advance money for said purposes; to carry on amy and all branches and business of builders; contractors and dealers in stone, brick, timber, hardware or any other building materials and requisites.
- (b) To buy, sell, discount and otherwise deal in, notes, bonds and other evidences of indebtedness whether the same be secured or not, and to buy, sell, discount and otherwise deal in mortgages and mortgage paper.
- (c) To conduct a general brokerage agency and commercial business for others in the purchase, sale and management of gale state for others, and the negotiations of loans, stocks, bonds and notes, and to negotiate loans thereon for others; to act as trustees in deeds of trust or mortgages on real or personal property and in any evidences of value to secure them, and to act as ggents for renting houses, lands, and the collection of rents and the payment of taxes.
- (d) To become and act as agent or broker or middleman for persons, firms or corporations in and about the purchase or sale of stocks, bonds, notes, bills of exchange of any and all kinds of personal property and choses in action, in any manner and to any extent and upon such terms and conditions and for such consideration as it may deem fit.
- (e) To establish and maintain an office or offices at its principal place of business for the conduct of its business and to establish and maintain branch offices at any other place or places as it may deem fit for the conduct of its business, or any of them.
- (f) Also, to do any other acts and kinds of business as are usually done and carried on in the City of Birmingham, Alabama, by persons, firms or corporations conducting a real estate, rental and loan business,.

Third: That said proposed corporation shall have no right, power or authority to manufacture, sell, keep for sale, or otherwise, dispose of, store, warehouse deliver or transport any prohibited liquors or beverages or to be in anywise concerned in the traffic therin; and if said corporation shall do or perform any act which it has herein specified that it cannot do or engage in, it will forfeit its charter

which may be declared in a suit in quo warranto.

Fourth: That the location of its principal place of business and its principal office in the State of Alabama is Birmingham, Jefferson County, Alabama, with such other and branch offices and places of business as it may deem fit and proper.

Fifth: hat the amount of the total authorized capital stock of mid proposed corporation is Two housand (\$2,000.00) Dollars, divided into twenty shares of the par v value of \$100.00 per share, allof which is Common Stock; and that said proposed corporation shall begin business with a paid in capital stock of One Thousand (\$1,000.00) Dollars.

Sixth: That M. L. McLaurine of Birmingham, Alabama, who will be the President of said corporation for the ensuing year, or until his successor is elected, is hereby designated to receive subscriptions to the capital stock of said proposed corporation.
