PIPE LINE PERMIT

KNOW ALL MEN BY THESE PRESENTS that I (we) Julia N.Thompson a widow, hereinafter referred as seller, for and in consideration of the sum of Two Hundred Sixteen Dollaes (\$216.00) and other good and valuable considerations, the receipt whereof being hereby acknowledged, do hereby grant unto the Southern Natural Gas Corporation hereinafter referred to as purchaser, a right of way to lay, construct, maintain, and operate a pipe line or lines, consisting of one or more pipes and appurtenances thereto, including telephone or telegraph lines in connection therewith, and the free right of ingress and egress to and fromsaid right of way for the purpose of laying, constructing, maintaining, repairing, replacing, operating or removing at will said pipe line and said appurtanances thereto, across the following described lands situated in Shelby County, Alabama;

Allthe southeast quarter (SE $\frac{1}{4}$) of Section three (3) south half (S $\frac{1}{2}$) of northeast quarter (NE $\frac{1}{4}$) and northwest quarter (NW $\frac{1}{4}$) of northeast quarter (NE $\frac{1}{4}$) of Section three (3) and north half (N $\frac{1}{2}$) of northeast quarter (NE $\frac{1}{4}$) of sectionten (10) and thirty (30) acres on west side of northwest quarter (NW $\frac{1}{4}$) of northwest quarter (NW $\frac{1}{4}$) of Section eleven (11) all in township twenty one (21) range three (3) west, Shelby County, Alabama containing six hundred sixty three (663) acres more or less, being the same land acquired and more fully described as per deed of record inBook 130 page 179 of the records of Shelby County, Alabama.

To have and to hold the same together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including all rights of ingress and egress as above set forth, and the right to cut and keep clear all trees that may injure or endanger said lines unto the saidpurchaser, its successors and assigns forever; provided, that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes hereinstated, then the easements hereingranted and all rights incident thereto shall terminate. Provided, further that the seller especially reserves the use and enjoyment of the premises hereindescribed, subject only to the exercise of the rights and privileges hereingranted to the purchaser. It is understood and agreed that purchaser shalllay said pipe line below plow depth wherever it crosses any land that may be cleared and in cultivation, and shall also lay said pipe line below plow depth across any land that may in the future be cleared and put in cultivation.

The location of said right of way on the above described land shall be determined by the purchaser, but said pipe line shall not be laid nearer than ___feet to any barn, residence or tenant house on said lands without written consent of the seller.

The purchaser shall pay all damages caused by its operations on said lands. It is further agreed by the purchaser that roads to be sused leading to lines across above described property on above described property shall be designated by the seller, it is further agreed that purchaser shallfurnish a map showing the exact location of said lines across above described property.


