TIMBER DEED

KNOW ALL MEN BY THESE PRESENTS, that the Alabama Mineral Land Company, a corporation chartered and doing business in the State of Alabama, under the laws thereof, in consideration of fight Hundred Fifty (\$850.00) Dollars to it paid by Roden Coal Company receipt whereof is hereby acknowledged has granted, bargained, and sold and by these presents does grant bargain, sell and convey unto the said Roden Coal Company all of the saw timber that is, timber which is three (3) inches or more in diameter outside the bark at the stump or base, measured one foot above the ground, on north half northwest quarter (N_{2}^{1} NW_{4}^{1}); Section four (4), township twenty two (22), south range four (4) west; also west half northwest quarter (W2 NW2); and northeast quarter northeast quarter (NE NE NE NE NE); Section nine (9), township twenty two (22) south, Range four (4) west acres more or less in Shelby County, State of Alabama, subject to the conditions, agreements and covenants here of to-wit: The cutting of said saw timber may commence at once; andmust be completed within forty eight (48) months from this date and that which has not been so cut and removed within said time shallrevert to and become the property of the grantor; and occupancy of said land by sid grantee is expressly limited to the time needed to cut said saw timber, but not beyond the time stated, and for the purpose of cutting said saw timber only, and allrights on said land shall cease as soon as said timber has been cut and removed; and grantee may remove houses and machinery put on said land if they are so removed within the time allowed for cutting and removing said timber.
