NOW THEREFORE, in consideration of the premises and the sum of Seven Hundred Fifty (\$750.00) Dollars in hand paid by Henry Ruff to O.A.Griffin and A.B.Griffin the receipt whereof is hereby acknowledged, we the said O. A. Griffin and A. B.Griffin do hereby grant, bargain, sell and convey to the said Henry Ruff all the timber 10 inches and up in diameter at 14 inches above the ground, sold to us by The Alabama Fuel and Iron Company on April 6, 1927, on the hereinafter described real estate, together with all our right, title, claim and interest in and to the said contract insofar as it affects the hereinafter described real estate, and in further consideration of the premises and the said sum of Seven Hundred Fifty (\$750.00) Dollars in hand paid by Henry Ruff to the said O.A. Griffin and A.B.Griffin the receipt whereof is hereby acknowledged, we, the said O. A. Griffin and wife, Lillie Griffin and A.BB.Griffin and wife Mamie Griffin, do hereby remise, release, quit claim and convey unto the said Henry Ruff all our right, title, interest and claim in and to the following described real estate situated in the County of Shelby, State of Alabama, to-wit:
