KNOW ALL MEN BY THESE PRESENTS that I (we) Alabama Lime and Stone Corporation hereinafter referred to as seller, for and in consideration of the sum of One and No/100 Collers (\$1.00) and other good and valuable considerations, the receipt whe reof being acknowledged, dohereby grant unto the Southern Natural Gas Corporation, hereinafter referred to as purchaser, a right of way to lay, construct, maintain and operate a pipe line or lines, consisting of one or more pipes, and appurtenances the reto, including telephone or telegraph lines in connection therewith, and the free right of ingress and egress to and fromsaid right of way for the purpose of laying, constructing maintaining, repairing, replacing, operating or removing at will said pipe line and said appurtenances, thereto, across the following described lands situated in Shelby County, Alabama: As our interest may appear in the northwest quarter (NW2) of southwest quarter (SW4) of Section twenty one (21) Township twenty two (22) south, range two (2) west.

To have and to hold the same together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof, including all rights of ingress and egress as above set forth, and the right to cut and keep clear all trees that may injure or endanger said lines unto the said purchaser, its successors and assigns forever; provided, that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes herein stated, then the easements herein granted and allrights incident thereto shall terminate.
