Whereas, upon said tract of land above described is located a public school house of the town of Wilsonville, A, abama, and



That the Mayor of the the Town of "ilsonville, Alabama, be and he is hereby authorized to execute and deliver to the State of Alabama, a deed to said poperty, conveying to said State of Alabama, all the right, title orinterest which said town of "ilsonville, Alabama, may have or own in said property.
- 2. That the signature of the Mayor to said deed shall be attested by the Town Clerk of said municipality.
- 3. That H. T. Dickens, as Mayor of said Town of Wilsonville, Alabama, is hereby authorized to execute said deed in the name of said town and to affix the corporate seal of said municipality thereto.

Now, therefore, in consideration of the premises and the further sum of one Dollar to the Town of "ilsonville, Alabama, in hand paid by the State of Alabama, the receipt whereof is hereby acknowledged and in further consideration of the contributions made by other persons for the purpose of securing the extension of aid by the State of Alabama, in the erection, repairing or equipment of the buildings on the lands in said resolution described, the Town of Wilsonville, Alabama a municipal corporation, has granted, bargained, and sold and by these presents does grant, bargain, sell and convey unto the State of Alabama, the following described real estate situated in Wilsonville SchoolDistrict Number 72, in Shelby County, Alabama, viz:


