necessary or convenient for the full enjoyment or use thereof, including all rights of ingress andegress as above set forth, and the right to cut and keepclear all trees that may injure or endanger said lines unto the said purchaser, its successors and assigns forever; provided that if the purchaser, its successors or assigns, should permanently abandon the use of said right of way for all of the purposes herein stated, then the easements herein granted and all rights incident thereto shall terminate. Provided, further, that hhe seller especially reserves the use and enjoyment of the premises herein described, subject only to the exercise of the rights and privileges here in granted to the purchaser.

It is understood and agreed that purchaser shall lay said pipe line below plow depth wherever it crosses any land that may be cleared and in cultivation, and shall also lay said pipe line below plow depth across any land that may in the future be cleared and put in cultivation.

The location of said right of way on the above described land shall be determined by the purchaser, but said pipe line shall not be laid nearer than 100 feet to any barn residence or tenant house on said lands without written consent of the seller.

The purchaser shall pay all damages caused by its operations on said lands.

This right of way to be 30 feet wide.
