 On the north by cross street south of a lot known as Mrs. Sallie Lawrence's lot,
 on the east by the land known as A. H. Weaver on the south by the lot of A. H. Weaver
 on the west by Main Street. The above house and lot is known as the J. H. Robertson
 home, and was known as the W. R. A. Milner house and lot; and more particularly known
 and described as one house and lot No. 86, as per map of W. J. Horsley's map of
